On **April 14, 2016**, a new vehicle damage disclosure rule goes into effect that will pertain to how, when and what must be disclosed when you sell vehicles.

Since May 2015, the CADA staff and the presenting attorney have been engaged in a stakeholder process advocating your interests and is presenting the finalized rule, a positive step forward in clarifying what was previously an extremely vague rule. There is great value in specifically excluding completed or prior mechanical repairs and general maintenance items, which CADA advocated to clarify and exclude.
